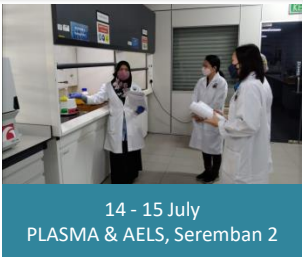

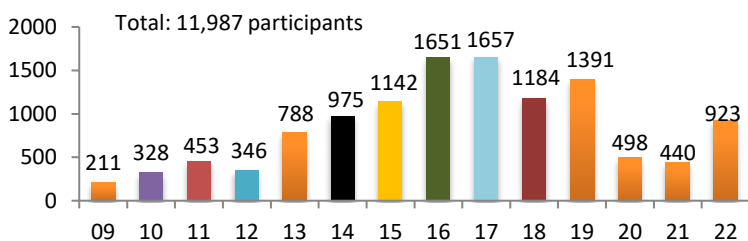

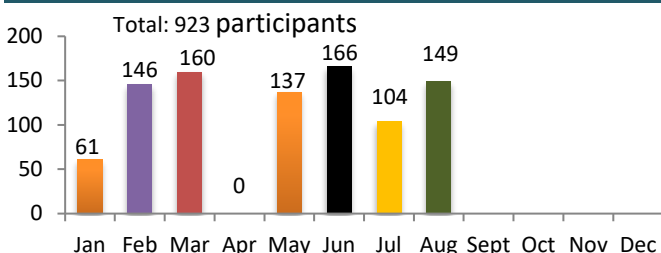

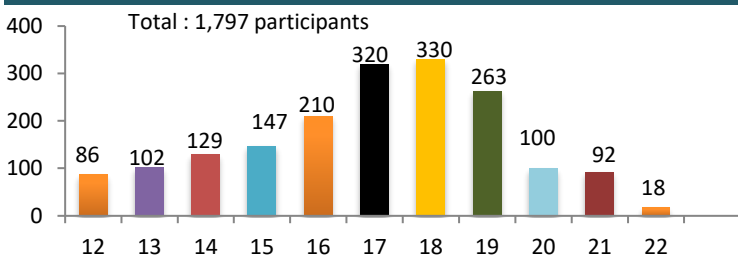
Total number of participants attending **CePSWaM Courses** from 2009 – 2022



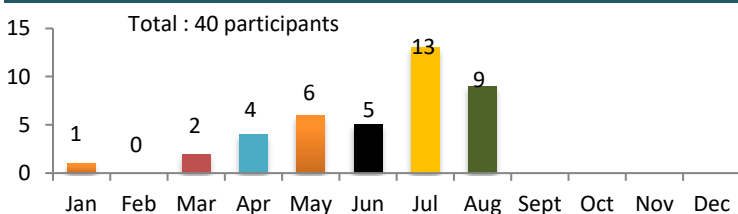
Number of participants attending **CePSWaM Courses** for Jan – Dec 2022



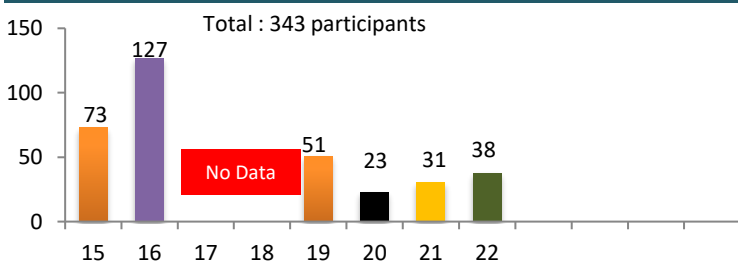
Number of participants attending **CePSWaM Technical Report Preparation Workshops (TRPW)** from 2012 - 2022



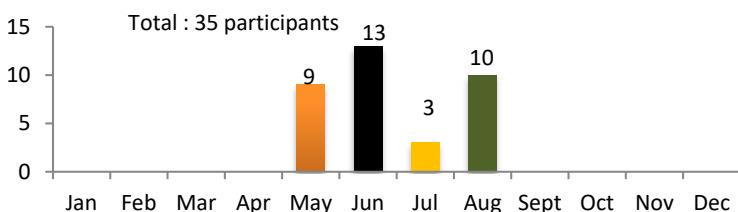
Number of participants attending **CePSWaM Technical Report Preparation Workshops (TRPW)** for Jan – Dec 2022



Number of participants attending **The Management and Handling of Scheduled Waste Course (SWM)** from 2015 - 2022

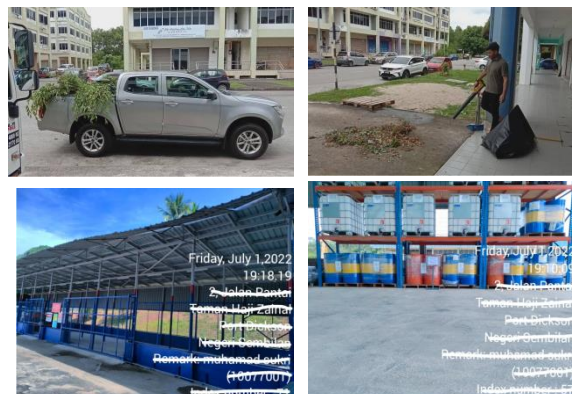


Number of participants attending **Workshop on the Preparation of Scheduled Waste Information (Waste Card)** for Jan – Dec 2022
