Notification of the SW generated and updated SW characteristics to DOE through eSWIS in accordance with Regulations 3 and 12 of EQSWR 2005.

Accurate and up-to-date inventory of SW generated in accordance with Regulation 11 of EQSWR 2005.

Implementation of sorting and segregation of SW incompatibilities in accordance with Regulations 9(1) and 9(2) of EQSWR 2005.

Performing appropriate packaging, labelling and storage of SW in accordance with Regulations 8, 9 and 10 of EQSWR 2005.

Assessment and implementation of SW minimization and reduction processes; through SW reuse, recovery and recycling and, application of special management of SW in accordance with Regulations 6 and 7 of EQSWR 2005.

Selection of SW prescribed premises for reuse, recovery, recycling, treatment and disposal in accordance with Regulations 4, 5 and 6 of EQSWR 2005.

Establishment of the SW storage facilities in accordance with Regulations 8 and 9 of EQSWR 2005.

Preparation of SW information (waste card) in accordance with Regulation 13 of EQSWR 2005.

Handling of SW spillage or accidental discharge by establishing the emergency response plan (ERP) under Regulation 14 of EQSWR 2005.

SW management training for staff of SW generator in accordance with Regulation 15 of EQSWR 2005 and SWM competency certification training in accordance with Section 49A(1)(b) of the EQA 1974 (Act 127).

SW management audit and inspection for compliances with EQA 1974 and EQSWR 2005.
